EFFECTS OF OVEREXPOSURE:

Acute: Nausea, dizziness. Odor may irritate nose, throat and respiratory tract of some persons.

SECTION VII - PRECAUTIONS FOR SAFE HANDLING AND USE

If Material is Spilled: Avoid contact with material. Persons not wearing appropriate protective equipment should leave the area of the spill until cleanup is complete. Stop spill at source, dike area to prevent spreading, pump liquid to salvage tank or drum. Remaining liquid may be taken up on clay, diatomaceous earth, sawdust, or other absorbant, and shoveled into disposal containers.
